

South Downs National Park Update

The South Downs National Park Inquiry re-opens on February 12th and is expected to continue until at least April.

At a pre-inquiry meeting in December, the Inspector emphasised that the inquiry should not be used as an opportunity for participants to argue that the Western Weald, of which the Parish forms a part, should form part of the National Park, since he considered that this fell outside the Secretary of State's terms of reference for the re-opened inquiry.

He did, however, say that he was ready to receive written submissions on the Western Weald so that Secretary of State is aware of the views of those who support its inclusion in the National Park.

The Parish Council does not consider that the Inspector's grudging concession goes far enough, and along with many other objectors is pressing the Inspector to hear evidence on the Western Weald in exactly the same way as on other new issues not considered at the original inquiry. The recommendation to exclude the A3 Corridor and the Rother Valley stems mainly from a report of the Inquiry's Landscape Assessor, who produced his report after the formal inquiry, had closed. His recommendations, which are also at variance with a wide range of other assessments, have, therefore, never been the subject of public scrutiny. The issue will be raised at the first day of the re-opened inquiry.

There continues to be a tremendous amount of support both from within the Western Weald and from outside individuals and organisations. When the Boundary proposed to the Government by Natural England was the subject of public consultation, there were only 2 objections, both from developers, compared with over 400 in favour of inclusion.

The issue is of vital importance to the village since the Landscape Assessor is arguing that Liss and the Rother Valley no longer meet the "natural beauty" criteria needed for inclusion in a National Park or an Area of Outstanding Natural Beauty (AONB). If, therefore Liss is excluded from the National Park, there is a real risk that it will lose its AONB protection, which has limited the amount of development in the village since the AONB's creation in the early 1960s.

A New Bus Shelter for Mill Road

We are happy to say that our application to EHDC for the release of Developers' Contributions Funds for an additional bus shelter, as reported in issue 20, was successful. The new shelter is an all oak construction that was built and installed by local craftsman Mark Probyn and was erected in December.

Use it or lose it....call to Liss commuters and others

The District Council is looking at all its assets and the Hill Brow Road car park is very under used and therefore under threat.

The car park behind Tesco and the other Lower Mead shops is always full before the shops open and after they have closed suggesting the users are Liss commuters. It would be very sad indeed if Liss was to lose at least part of the Hill Brow Road car park due to the lack of consideration for shoppers by commuters not using this EHDC car park.

If we were to lose this car park and the landowner of the shoppers car park in Lower Mead decided to reduce or limit car parking then the villagers of Liss would have even less available car parking in the future. The other car parks in Liss are usually full and the demand for on street car parking is high so any loss of car parks in Liss will exacerbate the situation.

Thus to ensure the valuable Hill Brow Road car park remains in its entirety for the use of all Liss people it is vital that the current utilisation is increased, hence this call to Liss commuters and others to use the Hill Brow Road car park.

Courtesy Crossings

Following on from the last issue, we have it on good authority that the installation of the courtesy crossing in the village centre outside Vision Vista and Pembrokes will occur very soon and by the time you read this it may already be in place. To compliment this crossing new dropped kerbs have been installed in Station Road close to the car park to allow easier access for those with buggies or using mobility vehicles. We should all be able to reach the Lower Mead shops more easily.

A word on Allotments.....

It is timely to welcome several new tenants to our allotment plots and wish them well in their growing endeavours and at the same time give a few reminders.

Good practice in terms of cultivation is expected, as well as management to deter certain kinds of wildlife particularly vermin. Many of nature's pests to the gardener such as pigeons, magpies, foxes, rabbits, deer etc. etc. are extremely difficult to control and netting of both the plastic and wire mesh type may be necessary to deter.

All allotments are inspected regularly and tenants contacted regarding any issues, particularly lack of cultivation over several weeks. This has to be done in view of the long waiting list for plots and if allotments are not kept up then after appropriate warning or discussion, cessation of the tenancy will result.

Awards are made each year in August by the Parish Council for 'best kept allotments'. Plots are inspected on an independent basis at least three times during the period April to July and points are awarded for plot tidiness, methods of cultivation, quality of crops and overall appearance.

For those who are not aware of the facility, Liss Horticultural Society operates a Trading Hut at Lower Green allotments on Rake Road which is open for an hour at 11.30 am each Saturday and Sunday from February to October, an excellent selection of horticultural products are available in sizes and prices better than Garden Centres & DIY stores. For the modest subscription of £5 annually you can avail yourself of this facility, as well as participate in the regular monthly meetings at The Triangle Centre, display your produce at the Spring, Summer & Autumn shows as well enjoy visits to many Garden attractions in the South of England including RHS at Wisley.

Liss Beat Surgery

Our local beat police officers are to hold a surgery at Liss Community Centre on Saturday 8th March between 3pm and 5pm. Members of the public will have a chance to discuss any matters of concern including anti-social behaviour and the future policing of Liss.

Liss Junior School is seeking new governors - could you help?

Liss Junior School needs members of the local community to join its governing body. The Governing Body is made up of fourteen people comprising staff, parents and other members of the local community. They set the overall strategic direction of the school and ensure that the school provides the best possible education for the young people of Liss and the surrounding area.

Each governor is appointed for a term of four years and we provide an informal mentor to help with the initial induction as there is a lot to learn, especially for those not familiar with the state school system. Extensive training is provided by Hampshire County Council, this usually takes place at Cosham. New governors can also expect to join at least one of our three committees focusing on Curriculum, Personnel and Buildings.

The full governing body meets twice each term and each committee also meets twice a term. These meetings are held at the school, usually on Tuesday or Thursday evenings starting at 6pm. The minimum commitment is to attend as many meetings as possible, but some governors also get more involved in the life of the school,

Precept 2008/09

At the December Council meeting, Councillors approved a precept of £132352 for the 2008/09 financial year. This is an increase of £3666, or 2.85%, over the 2007/08 charge. Allowing for the small increase in the number of band D houses in Liss this equates to a charge of £51.98 per house compared to £50.76 for 2007/08, an increase of £1.22 or 2.4%. This increase is significantly below the current annual RPI rate of inflation which is 4.0%. A full presentation of the budget will be made at the Annual Parish Meeting on 19th March.

Among the provisions for capital projects are sums for disability access footpaths to play areas, allotment regeneration at Princes Bridge & enhancements to the entrance of the Riverside Walk.
