68/21 Apologies

69/21 Declarations of interests

70/21 Internal Audit 20/21

The acting Chair of Finance noted that the reports highlighted that everything was in order as regards financial records and procedures. The Chair extended his thanks to the former RFO who had undertaken the preparatory work for the audit process.

71/21 Delegated arrangements

Resolved: That following the government's announcement on 14th June that Covid-19 restrictions are not being lifted until 19th July and the subsequent recommendation from HALC that meetings are kept to an absolute minimum until after this date, the Chair, Vice-Chair and Chair of Finance shall have delegated authority collectively to make decisions on behalf of the Council where such decisions cannot reasonably be deferred, must be made in order to comply with a commercial or statutory deadline or are required to ensure business continuity. The acting Chair of each Committee shall be assumed to be the incumbent until the first meeting of the relevant Committee in the Council year at which the Chair is appointed.

This will be carried out where possible in consultation with Members by electronic means. The delegation does not extend to matters expressly reserved to the Council in legislation or Standing Orders or Financial Regulations. Any decisions made under this delegation must be recorded in writing and must be published in accordance with the relevant regulations. This delegated authority ceases upon the first meeting of the Council after the Council meeting at which the delegation was put in place.
