This is a partnership between the Community Association and the Parish Council and we hope that as many people as possible from the village will come and support this much loved Christmas event.



NEWMAN COLLARD PLAYING FIELDS AND PAVILION

Report by the Newman Collard Playing Fields Trust.

Like Parkinson's Law, it is always the case that projects take longer than the planners thought. When the trustees of the Newman Collard Trust first presented their ideas to the Parish Council a year ago, they estimated that by now planning permission would have been granted and major funding would be well underway. Sadly, the untimely death of our project manager meant that we were unable to keep up with what was already a very tight schedule. We have since obtained the services of another expert who has a great deal of experience in this field. The final details of the design of Phase 1, which is the extension and renovation of that part of the pavilion currently used by the football club, have been negotiated with current users but very much with an eye to the future and making the other 'end' of the building a multi-user facility. Although the rebuild is still some time a way, perhaps those 'shakers and movers' in Liss who would like to set up a new sporting or recreational facility, such as keep fit or martial arts clubs, might like to contact the Trust to express any interest they might have in using the improved facilities when they become available.

On the financial side, all the grants we bid for to allow us to finance the infrastructure costs have been agreed and we are particularly grateful to both the Parish Council and East Hampshire District Council for their support. We have also had generous gifts from local individuals and organisations. With the granting of planning permission we will be able to go to major fund providers to raise the money to enable renovation to commence.

For some time we have been in discussion with both the Charity Commission and the Parish Council over an updated constitution for the Trust, replacing that which has been in place since the early 1960s. Our aim is to make it easier for villagers to express their views on the strategy the Trust pursues and at the same time to make the constitution a more comprehensive document. This has proved to be a slow business, as we wish to take into account the constructive suggestions of parish councillors as well as the mandatory requirements of the Charity Commission.

LISS - SIGNS OF LESS CLUTTER

Over the past year or so following an audit of the signage in Liss undertaken by residents, the Parish Council has been working with Hampshire County Council (Highways East) to reduce the number of signs and road-side "clutter" in the village.

This has been achieved by pole sharing of signs, and by removing unnecessary and duplicate signs such as those indicating a "slippery road surface". The signage has also been tidied up at the car parks in Hillbrow Road and Station Road, and on roads where we no longer have bus routes the redundant bus stop poles and signs have also been taken away. This action has resulted in a marked "de-cluttering" of the roadsides within the Parish making our village look tidier, and should improve road safety as drivers will not be distracted by

Hopefully, the next action will be to remove a number of poles that don't have any signs on them from around the village.

Here in Liss we have taken action to reduce the roadside "clutter" which The Campaign to Protect Rural England (CPRE) has long been advocating.

LISS ROMAN VILLA PROJECT

Report by Liss Archaeology Group.

The dig for September 2006 is now complete and was thoroughly enjoyed by all who took part, and we are all anxious to see and hear the report to be produced by George Anelay, our professional archaeologist, during the November Liss Archaeology Group (LAG) Members meeting.

The 'villa' has not been located but it cannot be far away from where the dig was conducted this year since in this year's trench we have been able to relate previous findings with new findings. This has identified two Roman bathhouses and another Roman building – probably

used for accommodation, in addition to other finds like a broach, a bracelet, a bell and an array of coins, tiles and pieces of pottery.

The 'well', that is only partially excavated, has revealed the skeleton of a dog (see photograph). The skeleton has been verified by our animal bone expert, Sheila Hamilton-Dyer, as that of a dog, and not a wolf or fox. The dog was male and prior to dying had been gnawing on a beef bone – the contents of the stomach cavity revealed the bone fragments.

Perhaps next year will reveal the 'villa' – keep on digging.



ALLOTMENTS

With declining temperatures and shortening days gardeners can look back on the growing season and adjudge their efforts in what was a very challenging year, starting from a cold spring, followed by very little rainfall from May onwards and record temperatures during July. August rains were insufficient to replace the loss of soil moisture and redress the yields of many crops.

Results have been varied, top fruit has been alright on established trees but with reduced yields, autumn soft fruit crops have been up to expectations or better in some instances - blackberries came into crop up to 3 weeks early.

So with this years results in mind it's time think about the start of the next gardening year which traditionally begins now in October. After a review of crop locations it will be time to start digging to remove perennial and annual weeds that still linger and turn the ground to the state where nature takes over and breaks down the soil to a friable mass.

Winter evenings are times to contemplate the new season's seed catalogues, and the possibility of trying new varieties and different crops for next year, and a good opportunity to consider joining a local horticultural society, many of whom have schemes that offer members discounts on seed purchases.

Renewals for allotment plots take place early in the New Year and by the end of February the Parish Office has details of plots that are not being retained and are available for re-letting. There are some 80 plots of varying size spread over a number of locations around the village and many of the allotments on the various sites have been worked by their holders for many years.

A word of caution for first timers, after contacting the Parish Office to ascertain availability of plots, go and see what is on offer, check the size and depending on its condition try to estimate how many hours or over what period of time it will take to bring the plot into a manageable and cultivated state. Do not take an allotment just because it is the only one available at the time, far better to be patient rather than find other demands on your time such as a young family prevent you undertaking all your growing intentions. Here's to next year, the evenings will soon be getting lighter after Christmas and all the growing fun can start again.
