By completing the enclosed questionnaire and providing us with the greatest amount of information, opinions and ideas on a full range of issues you will be contributing to the future shape/role of the village and community. All this information will then be combined with past research and the feedback gained from the exhibition held in June 2011 to formulate a comprehensive Parish Plan with a strong evidence base. The projects that come forward will form our Action Plan within the Parish Plan.

National Park Authority (SDNPA). The Parish Plan will provide useful and important evidence for seeking future funding either through developers contributions, the Community Infrastructure Levy (CIL) or other opportunities that may arise eg SDNPA. Increasingly when applying for grants both locally and nationally the various projects have to be shown as having a strong evidence base.

Once adopted by the Parish Council the Parish Plan will then be endorsed by the South Downs

The Village Plan and Design Partnership has undertaken the task of producing our Parish Plan on behalf of Liss Parish Council and Villagers. It has had a long gestation but we want to have it completed by the end of this year.

Ongoing Liss Parish Council Projects

Liss Parish Council has two current projects and we would appreciate your answers to the associated questions at the end of the enclosed questionnaire.

Skatebowl

For more than 10 years LPC has been trying to provide a facility for young people as identified in the Village Design Group workings on the 2000 Village Design Statement. This would be in the form of a concrete bowl buried in the ground and be around 19m by 12m and 1.2m deep in size. The latest costings for the project suggests an investment of at least £73,000 of which £56,000 is agreed funding, provided that a suitable site can be found. It should be visible so it can be monitored and far enough away from homes not to cause a noise nuisance.

To go ahead with the project LPC will still need to identify a suitable parcel of land that meets all the requirements, produce a plan, invite tenders for design and construction from suitably experienced companies and select a supplier, ensure there is funding for the life of the project including its on-going maintenance and management. Any implementation will need to adhere to and follow all the necessary legal, planning and development procedures.

We realise that over the last 11 years this issue has caused division amongst the residents but as your Parish Council it is one of our duties to provide facilities for all.

In the light of the recent exhibition and the fact that this project has been in existence for so long we need to reassess the demand within the village for such a facility, and therefore ask you to answer the questions posed.

West Liss Pavilion

The proposal is to have a new building owned and managed by LPC to replace the existing West Liss Pavilion and 1st Liss Scout Hut both of which are in a very poor state. The new purpose built facility using the same location / site foot print would accommodate all existing users and hopefully encourage new users as well.

The new building is urgently required and the intention is to provide it within 3 years. We believe such a building will cost in the region of £250,000 so funding such a major project is the biggest issue.

Progress is being made by way of appointment of an architect to draw up full plans in order to obtain planning permission, as without achieving this initial stage it is not possible to start applying for funding. LPC have set aside funds to meet this first stage of the project.

LPC and the user groups will seek funds from all sources including local authority, commercial sponsors, sports associations, lottery, as well as donations and public fund raising. It is probable that there will be a short fall particularly on such a big project that is designed to encompass requirements for the widest of village user population and create interest from outside groups to support its future viability.

At the recent June 2011 exhibition a suggestion was put forward to meet such a monetary shortfall by increasing the LPC precept (Council Tax) for a limited number of years. For example an increase of £15 per annum which is equivalent to 29p per week for a band D house for 2 years would raise £78,000. The money raised would be ring fenced for this project.

The proposal has not yet been discussed by LPC, but will be considered when LPC sets the budgets for 2012/13 and 2013/14. We are therefore asking the residents of Liss for their answers to the questions posed.

OVERGROWN HEDGES A Timely Reminder...

We all appreciate the very rural feel of Liss which is achieved through its very many hedges, but they do require cutting back and regular maintenance which is the responsibility of the residents. This cutting back is particularly important where the hedges act as boundaries alongside pavements so that pedestrians and those using prams, buggies, or mobility vehicles can move about easily without getting caught up on any overgrown/overhanging vegetation. Such pruning is also essential at road junctions to maintain adequate sight lines for all road users.

Crossover

Crossover is now in its 6th year and as we approach the start of a new school year will be receiving a new intake of young people. The admission criteria have been slightly altered as young people tend to like to be with their friends and this does not always fit with criteria based entirely on age. The centre runs two sessions each weekday which are free: 4.30pm to 6.30pm for young people in school years 5 to 7 and the 7pm to 9pm session for those in school years 8 to 11. Regular craft and skills sessions and other interesting programmes for all ages are advertised in the Centre.

As some older volunteers are retiring we are urgently seeking new volunteers to work with us and the young people. It is rewarding work and even those only able to assist once a month are very welcome to join the team. Saving you money, keeping you warm

East Hampshire District Council is working in partnership with Hampshire County Council and the other Hampshire District Councils to deliver 'Insulate Hampshire'. This is a new area based insulation scheme aiming to save you money on your energy bills and keep launched in July 2011.

It offers cavity wall insulation for £75 for at least the first 5,000 householders to sign up to the scheme and will be £99 after that. Loft insulation is available from £99* where you currently have less than 60mm or from £49* if you currently have some but would like to top up your existing loft insulation with rolls of 'DIY' insulation.

*Loft Insulation at £99 (for professional installation) and DIY rolls of loft insulation, are based on a free technical survey of an average 3 bedroom semi detached property and will be loft spaces.

Dog fouling - Clean it up please

Liss has again become the target of irresponsible dog owners this Summer: East Hampshire District Council have received complaints about fouling on the routes from the village centre, West Liss Recreation Ground and Newman Collard playing fields.

Why and where should I clean up after my dog?

It is an offence under the Dogs (Fouling of Land) Act 1996 not to clear up immediately after your dog has fouled on all land, both public and private, to which the public has access. These include:

*highways (including private roads) and footways *open spaces *playing fields/public parks/play areas *housing amenity greens public footpaths, bridleways and adjoining verges.

Dog fouling in public areas is anti-social, it is unpleasant to look your home warm and comfortable and was at, smells, attracts flies and is associated with a number of diseases including Toxoxariasis, which can result in blindness.

> Offenders may be prosecuted in a magistrates court with a maximum penalty of £1,000. It is no defence to claim ignorance of the law, or of the dog's actions. Guide dog owners are exempt. EHDC officers regularly patrol Liss and, if you are caught failing to clean up after your dog by them, they may give you the option of paying a fixed penalty of £50 within 14 days.

How do I clean up after my dog?

Firstly, be prepared - always carry a poop-scoop or bag, a carrier bag will suffice, and follow these simple guidelines: Place hand in plastic bag,

Pick up dog waste in its entirety using plastic bag,

Turn the bag inside out so dog waste is inside & tie the bag up.

There are special bins provided at the village recreation grounds and at other locations, but any bin will do. Leaving a bag of dog waste on the ground is still an offence.

Please help us achieve our aim to eradicate dog fouling by being subject to an excess meterage charge for larger a responsible dog owner, so everyone can enjoy the surroundings in Liss.
